

**TOWNSHIP OF NORTH BRUNSWICK  
RESOLUTION 318-10.25**

**Authorizing an Agreement with Standard Insurance Company**

**WHEREAS**, the Township of North Brunswick currently provides life insurance coverage to Township employees, the Library staff and emergency volunteers under a plan with Standard Insurance Company; and

**WHEREAS**, the current authorized plan with Standard Insurance Company expired August 31, 2025; and

**WHEREAS**, the Township's insurance broker, has reviewed options for life insurance coverage and has made a recommendation to continue with the current provider which has extended the current rates offered for the new plan years, beginning September 1, 2025; and

**WHEREAS**, contracts for an insurance plan awarded by the governing body of a local unit may be retained without competitive bidding pursuant to Public Contract Law N.J.S.A. 40A-11-5(1)(m) et seq. in accordance with the requirements for extraordinary unspecifiable services; and

**WHEREAS**, pursuant to Public Contract Law N.J.S.A. 40A-11-15(6) et seq. a local unit may contract with any insurance company authorized to do business in this State for any term of not more than three years; and

**WHEREAS**, the contract shall be kept on file and available for public inspection.

**NOW THEREFORE BE IT RESOLVED**, by the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey hereby authorizes and confirms the following:

1. The Township hereby authorizes the Mayor and/or Business Administrator to enter into a contract with Standard Insurance Company to provide life insurance coverage for eligible Township employees, the Library staff and emergency volunteers,
2. The term of this agreement shall be for 24 (twenty-four) months commencing September 1, 2025 through August 31, 2027,
3. This agreement is contingent upon the appropriation of funds in the FY2026 budget and future fiscal years, estimated to be \$30,000.00/year based on current enrollment,
4. The Mayor and/or Business Administrator and Township Clerk, together with appropriate officers, employees, professionals and staff of the Township are hereby authorized and directed to take all steps necessary to effectuate the purposes of this Resolution,

- 5. It is hereby directed that Notice of Award of this contract shall be published in the Home News Tribune as the official designated newspaper of the Township within ten (10) days of adoption; and
  
- 6. This Resolution shall take effect immediately.
