Authorizing an Intergovernmental Transfer to Appoint a Police Officer from the Township of Bloomfield to the North Brunswick Township Police Department

WHEREAS, a vacancy exists in the title of Police Officer within the North Brunswick Township Police Department; and

WHEREAS, the Township seeks to fill said vacancy through an Intergovernmental Transfer pursuant to New Jersey Civil Service Commission ("NJCSC") rules and procedures; and

WHEREAS, Officer Morgan A. Ziegler currently serves as a permanent, Civil Service Police Officer with the Township of Bloomfield, holds a valid Police Training Commission (PTC) certification, and meets all statutory, regulatory, and departmental qualifications for transfer; and

WHEREAS, the Public Safety Director recommends the appointment of Morgan A. Ziegler by Intergovernmental Transfer, subject to completion of all standard pre-employment verifications, including a background investigation, medical/psychological evaluation, drug/alcohol screening, and firearms qualification, and subject to NJCSC approval; and

WHEREAS, the Officer shall be placed at Step 2 under the PBA Local 160 collective bargaining agreement ("CBA"), with salary and benefits administered in accordance with the CBA, NJCSC rules, and Township policy; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available in the Police Salary & Wage appropriation to support this appointment for the remainder of the fiscal year.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, that:

- 1. The Township hereby authorizes an Intergovernmental Transfer to appoint Morgan A. Ziegler from Township of Bloomfield to the title of Police Officer with the North Brunswick Township Police Department, effective November 15, 2025 or as soon thereafter as practicable following NJCSC approval and completion of all pre-employment requirements.
- 2. The Officer shall be placed at Step 2 under the PBA Local 160 CBA. Salary, benefits, seniority, and leave accruals shall be administered in accordance with applicable law, NJCSC rules, and the CBA. Nothing herein alters management rights or bargaining-unit jurisdiction.
- 3. The Business Administrator as the Appointing Authority is hereby authorized to execute NJCSC Intergovernmental Transfer forms/agreements and any ancillary documents necessary to effectuate the transfer, together with non-substantive amendments consistent with this Resolution.
- 4. The Municipal Clerk, Personnel, and Police Department are authorized to take all administrative actions needed to implement this appointment upon approval.
