

**TOWNSHIP OF NORTH BRUNSWICK
RESOLUTION**

Authorizing A Proprietary Contract with Flock Safety for Automated License Plate Reader (ALPR) Technology and Related Services with a One (1) Year Term at \$35,000 and with Two (2) One-Year Renewal Options

WHEREAS, the Township of North Brunswick seeks to enhance public safety and investigative capabilities through the use of an automated license plate reader (ALPR) system, associated hardware, software, data services, hosting, and support; and

WHEREAS, Flock Safety provides a proprietary, integrated ALPR platform consisting of hardware devices, hosted software, analytics, secure networking, and maintenance/services that interoperate as a unified system; and

WHEREAS, pursuant to N.J.S.A. 40A:11-5(1)(dd) of the Local Public Contracts Law, contracts may be awarded without competitive bidding for the provision or maintenance of proprietary computer hardware and software; and

WHEREAS, the Purchasing Agent has determined and certified that this procurement constitutes the provision and maintenance of proprietary computer hardware and software and that the value of the contract exceeds \$17,500.00; and

WHEREAS, the Police Director has recommended acquisition of the Flock Safety ALPR solution for an initial one (1) year term in the amount of \$35,000, with the option for up to two (2) additional one-year renewal terms at \$35,000 per renewal, subject to annual appropriation and satisfactory performance; and

WHEREAS, prior to contract execution, Flock Safety shall provide all required compliance documentation, including but not limited to a New Jersey Business Registration Certificate, Business Entity Disclosure Certification and other Pay-to-Play certifications as applicable under N.J.S.A. 19:44A-20.5 et seq., as well as Affirmative Action documentation; and

WHEREAS, the Chief Financial Officer has certified that funds in the amount of \$35,000 shall be made available for the initial contract term from Police Forfeiture Trust funds, subject to County Prosecutor approval.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, that:

1. The Township hereby awards a proprietary contract to Flock Safety for ALPR hardware, software/platform subscription, data services/hosting, and related support/maintenance for a one (1) year term in the amount of \$35,000, pursuant to N.J.S.A. 40A:11-5(1)(dd).
2. The Township further authorizes up to two (2) one-year renewal options, each at \$35,000, to be exercised at the sole discretion of the Township, contingent upon the availability and appropriation of funds within the current fund budget/or grant funding

opportunities, continued need, and vendor performance, for a total potential term of three (3) years and total potential amount of \$105,000.

3. The Mayor and/or Business Administrator, are authorized to execute the contract, purchase order(s), and any ancillary documents consistent with this Resolution, together with any non-substantive amendments as may be necessary to effectuate the intent herein.
4. This award is subject to Flock Safety's submission of all required statutory and regulatory documents, including Pay-to-Play compliance and Business Registration, and to adherence by the Police Department to applicable laws, the New Jersey Attorney General guidelines, and Township policies governing the use, retention, and sharing of ALPR data.
5. The Business Entity Disclosure Certification, Determination of Value, and other required documents shall be placed on file with this Resolution.
6. The Municipal Clerk shall cause notice of this action to be published in the official newspaper of the Township as required by law.
