Authorizing the Transfer of a Surplus 2015 Chevrolet Tahoe from the Township of North Brunswick to the Borough of Highland Park

WHEREAS, the Township of North Brunswick is the owner of a 2015 Chevrolet Tahoe, Vehicle Identification Number (VIN) 1GNSK3KC7FR280507, which was previously utilized by the Township for official purposes; and

WHEREAS, the vehicle has reached the end of its useful life for Township operations and has been determined by the Department of Public Works to be of no commercial or resale value to the Township, as evidenced by the attached *Certification of No Value*; and

WHEREAS, pursuant to N.J.S.A. 40A:11-36(2), the governing body of a contracting unit may authorize the transfer or sale of personal property not needed for public use, and of nominal or no value, to another local unit without advertising for bids; and

WHEREAS, the Borough of Highland Park has expressed interest in acquiring said vehicle for municipal use, and the Township finds it in the public interest to convey ownership to the Borough at no cost, thereby promoting intergovernmental cooperation and the continued public benefit of the vehicle;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, as follows:

- 1. The Township hereby authorizes the transfer of the 2015 Chevrolet Tahoe (VIN: 1GNSK3KC7FR280507) to the Borough of Highland Park, at no cost, having been determined to be of no value to the Township.
- 2. The Mayor and Township Clerk are hereby authorized to execute any documents necessary to effectuate this transfer, including the title and bill of sale.
- 3. The Township's Business Administrator, Department of Public Works, and Finance Office shall update all asset records to reflect the removal of this vehicle from the Township's inventory.
- 4. A copy of this resolution and the attached Certification of No Value shall be kept on file in the Office of the Township Clerk for audit purposes.
