

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING
THE ADVERTISEMENT FOR RECEIPT OF BIDS UNDER THE DEPARTMENT OF
PUBLIC WORKS FOR BID25003 – FUEL PUMP STATION**

WHEREAS, the Township owns and operates a Fueling Facility located at the Public Works Facility on Quarry Lane which dispenses gas and diesel fuel for municipal operations (vehicles, equipment, generators) as well as servicing the Board of Education, local Volunteer Fire Departments, and the North Brunswick First Aid and Rescue Squad; and

WHEREAS, the Director of Public Works has advised that the fuel pump station is approaching 30 years old and is in need of upgrades to the underground storage tanks, equipment, and related software; and

WHEREAS, CME Associates was authorized via Resolution no. 157-5.24 to provide professional services relating to site work, preliminary design, and bid design for a Fueling Facility that will transition to aboveground fuel storage tanks in accordance with NJDEP regulations; and

WHEREAS, designs and approvals are nearing completion and the Director has advised that the Department is ready for the procurement stage of the project to remove existing underground fuel storage tanks and install updated: fuel dispensing equipment, canopy for the dispensing equipment, monitoring equipment, and site work; and

WHEREAS, funding for said services, a cost estimate of which is attached to this resolution, is available in Account No.'s C-0455-C20-210-701, C-04-55-C22-230-101, and C-04-55-C24-240-701; and

WHEREAS, the Business Administrator has reviewed the Director's request and recommends authorizing a contract for the replacement of the Township's fuel pump station; and

WHEREAS, the aggregate amount for said goods and services is anticipated to exceed the current bid threshold, and is therefore required to be procured under a formal process pursuant the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

NOW, THEREFORE, BE IT RESOLVED, on this 18th day of February, 2025 that the Township Council of the Township of North Brunswick does hereby authorize advertisement for the receipt of bids for the following specification:
