

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
CONFIRMING THE APPOINTMENT OF DIANNE WALKER  
AS DEPUTY TAX ASSESSOR**

**WHEREAS**, a municipal tax assessor is responsible for the assessment of real estate within a municipality, with the objective to provide equality in the distribution of a levy which includes for North Brunswick the following levies; municipal, school, county, library and open space; and

**WHEREAS**, in June of 2002, pursuant to Resolution 240-6.02, Dianne Walker was first appointed Tax Assessor after the retirement of Ruth Mihalenko; and

**WHEREAS**, in November of 2019, Dianne Walker retired leaving a vacancy in position; and

**WHEREAS**, in December of 2019, pursuant to Resolution 314-12.19, Assistant Tax Assessor Alaina Wysocke was appointed to the position *Deputy* Tax Assessor; and

**WHEREAS**, in October of 2021, pursuant to Resolution 302-10.21, Alaina Wysocke was appointed to the position Tax Assessor, with a four-year term retroactive to July 2021; and

**WHEREAS**, in addition to having a Tax Assessor, it is in the best interest of the Township to have a Deputy Tax Assessor with express authority in the absence of the Tax Assessor; and

**WHEREAS**, in September of 2022, pursuant to Resolution 271-9.22, Dianne Walker was hired back as a part-time Assistant Tax Assessor and appointed to the position *Deputy* Tax Assessor, filling the unexpired Deputy Tax Assessor term ending June 30, 2024; and

**WHEREAS**, Dianne Walker has completed the unexpired term and it is the Mayor's recommendation to reappoint Assistant Tax Assessor Dianne Walker to the position Deputy Tax Assessor with a new term, retroactive to July 1, 2024; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-148 *Tax and Deputy Assessors*, every municipal tax assessor and deputy assessor shall hold office for a term of four years from the first day of July following appointment.

**NOW THEREFORE, BE IT RESOLVED**, on this 3<sup>rd</sup> day of February 2025, the Township Council of the Township of North Brunswick does hereby consent to the Mayor's appointment of Dianne Walker to the position Deputy Tax Assessor with a new term retroactive to July 1, 2024.

**BE IT FURTHER RESOLVED**, the initial and continued appointment authorized by this Resolution shall be subject to and conditioned upon Dianne Walker holding and maintaining certification as a Tax Assessor.
