

**RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AWARDING A NON-  
FAIR AND OPEN PROFESSIONAL SERVICES CONTRACT WITH  
ARI L. LOCKSPEISER  
TO SERVE AS MUNICIPAL PROSECUTOR**

**WHEREAS**, the Township of North Brunswick has a need to acquire a professional to perform the duties of Municipal Prosecutor for calendar year 2025; and

**WHEREAS**, on September 16, 2024, the Township Council approved Resolution 289-9.24, authorizing the solicitation of Requests for Proposals (RFP) for said professional services; and

**WHEREAS**, services were procured in formal manner in accordance with Local Public Contracts Law N.J.S.A. 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

**WHEREAS**, on Thursday, November 14, 2024, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of one (1) proposal that was later withdrawn by the firm; and

**WHEREAS**, the Township desires to contract for said professional services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 et seq.; and

**WHEREAS**, Ari L. Lockspeiser with the firm Wysoker, Glassner, Weingartner, Gonzalez and Lockspeiser, having an address at 340 Georges Street, New Brunswick NJ 08901, has agreed to perform the duties of Municipal Prosecutor for calendar year 2025; and

**WHEREAS**, Ari L. Lockspeiser has completed and submitted a Business Entity Disclosure Certification which certifies that the contract will prohibit Ari L. Lockspeiser from making any reportable contributions through the term of the contract.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, as follows:

1. The Mayor and/or Business Administrator is hereby authorized to execute, and the Township Clerk to attest to, a contract with Ari L. Lockspeiser to perform the duties of Municipal Prosecutor.
2. Compensation for services shall be paid at an rate of \$350.00 per session for regularly scheduled and special sessions and reimbursable expenses in an amount not-to-exceed \$70,000. Plea by Mail caseload shall be processed and included as part of the \$350.00 per session rate.

3. This contract is awarded without competitive bidding as a professional service in accordance with N.J.S.A. 40A:11-5(1)(a)(i) because the services are specialized and qualitative in nature, requiring expertise, extensive training, and proven reputation in the field.
4. A notice of this action shall be published in the Home News & Tribune as required by law within ten (10) days of its passage.
5. The Business Entity Disclosure Certification and Determination of Value shall be placed on file with this resolution.
