# A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AGREEMENT WITH MRC INC. TO PROVIDE AND INSTALL A NEW PLAYGROUND STRUCTURE AT EISENHOWER PARK UNDER ESCNJ CONTRACT

**WHEREAS,** North Brunswick's Department of Public Works' Parks Division is responsible for the maintenance and improvements of the Township's 25 parks; and

**WHEREAS**, the Parks Division has indicated that the existing play structure at Eisenhower Park is aging and should be replaced; and

**WHEREAS**, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

**WHEREAS,** MRC Inc., P.O. Box 106, Spring Lake, NJ 07762, is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #24/25–01 for Playground Equipment, Site Furnishings, Outdoor Circuit Training Equipment and Related Products; and

**WHEREAS,** MRC Inc., under Bid #24/25–01 has provided a proposal to provide a new custom playground structure, fiberglass sign, and their installation, at a total cost of \$52,456.28.

**NOW THEREFORE BE IT RESOLVED,** that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with MRC Inc. for \$52,456.28 for a new custom playground structure, fiberglass sign, and their installation.

**BE IT FURTHER RESOLVED,** that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with MRC Inc. in accordance with the previously approved Educational Services Commission of New Jersey Co-Op Bid #24/25–01.
