

**TOWNSHIP OF NORTH BRUNSWICK
RESOLUTION**

Authorizing an Agreement with Pellegrino Chevrolet For the Purchase of One 2026 Chevrolet Tahoe For the Department of Public Works Under the New Jersey Cooperative Purchasing Alliance – NTE \$58,251.46

WHEREAS, the Sewer Department is responsible for maintaining the Township's sewer system and responding to sewer emergencies; and

WHEREAS, the Director of Public Works has indicated that the Sewer Department's Vehicle #815 (2008 Ford F-250) requires replacement by a comparable vehicle; and

WHEREAS, the Township of North Brunswick is currently a member of the New Jersey Cooperative Purchasing Alliance #CK04; and

WHEREAS, Pellegrino Chevrolet, 1000 Gateway Blvd, Westville, NJ 08093, is an approved vendor under the New Jersey Cooperative Purchasing Alliance #CK04, Contract #24-43 for Cars, Crossovers, Class 1 – 3 Pickup Trucks/Chassis, Sport Utility Vehicles, and Vans; and

WHEREAS, Pellegrino Chevrolet, under Contract #24-43, has provided a proposal to provide one 2026 Chevrolet Tahoe SSV a total cost of \$58,251.46.

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with Pellegrino Chevrolet for \$58,251.46 for the purchase of one 2026 Chevrolet Tahoe SSV.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Pellegrino Chevrolet in accordance with the previously approved New Jersey Cooperative Purchasing Alliance #CK04, Contract #24-43.
