

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING
CHANGE ORDERS NO. 4 & NO. 7 WITH ENVIRONMENTAL CLIMATE CONTROL
("ECC") FOR THE MUNICIPAL COMPLEX HVAC PROJECT UNDER BID24002**

WHEREAS, Hurricane Ida impacted New Jersey on Wednesday, September 1, 2021, bringing severe weather conditions including strong winds and heavy and sustained rainfall in some areas; and

WHEREAS, the storm caused severe damage to municipal facilities, infrastructure, vehicles and equipment, including the Municipal Complex which had extensive damage to components of the heating ventilation and air conditioning (HVAC) system including; air handlers, chillers, ductwork and controls; and

WHEREAS, on February 5, 2024, pursuant to Resolution 73-2.24, the Township Council authorized Contract BID24002 with Environmental Climate Control ("ECC") of Wallington, New Jersey in the amount of **\$3,997,000.00** for the base bid, *not including* bid Alternate 1 for third floor Air Handler Unit ("AHU") in the Administrative wing in the amount of \$640,000.00 and Alternate 2 for third floor Air Handler Unit in the Police wing in the amount of \$340,000.00; and

WHEREAS, following the award of contract, James Mieth with T&M Associates, engineering firm for this project, met with representative for ECC and reviewed the project scope and timeline for the supply and installation of Air Handler Units under the bid alternates; and

WHEREAS, with an estimated manufacturer lead time of 26-30 weeks for the Air Handler units, ECC agreed to provide the equipment and labor cost breakdown for the bid alternates:

Alternate 1 \$640,000.00: AHU and Delivery \$324,500.00 / Labor \$315,500.00

Alternate 2 \$340,000.00: AHU and Delivery \$ 82,500.00 / Labor \$257,500.00

WHEREAS, on February 20, 2024, pursuant to Resolution 79-2.24, the Township Council authorized amending the contract award with ECC, awarding equipment under Alternate 1 for third floor Air Handler Unit in the Administrative wing for \$324,500.00 and equipment under Alternate 2 for third floor Air Handler Unit in the Police wing for \$82,500.00, for a revised contract award total **\$4,404,000.00**; and

WHEREAS, following the award of contract, the contract with ECC has been amended and approved for the following change orders:

WHEREAS, in December of 2024, during a progress review with T&M Associates and municipal officials, supplemental work was identified and ECC provided proposals (Change Orders No. , 5, 6, 7) to complete said work; and

WHEREAS, the Township’s mechanical engineer has advised that the Township authorize Change Orders No. 4 and 7 (delineated below);

Description	Amount
Change Order 4: Install Grilles, Flex, Collars, etc.	\$12,500.00
Change Order 7: Furnish & install two ductless splits	\$42,500.00

WHEREAS, the Township’s mechanical engineer also advised that additional discussions are needed to determine the scope of work to be detailed at a later time in Change Orders No. 5 & 6; and

WHEREAS, T&M Associates and municipal officials have reviewed the scope of work as presented by ECC, incorporated into Change Orders No. 4 & 7 and hereby make a recommendation to award said work as necessary for full remediation of the Municipal Complex HVAC system.

NOW THEREFORE, BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor or Business Administrator to execute Change Orders No. 4 & 7 with Environmental Climate Control for the Municipal Complex HVAC Project Bid, under Contract BID24002, with an increase in the contract amount by **\$55,000.00** for said work, for a revised contract amount of **\$5,569,434.00**.
