

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING  
THE ADVERTISEMENT FOR RECEIPT OF BIDS UNDER THE DEPARTMENT OF  
PUBLIC WORKS FOR BID25006 – MUNICIPAL COMPLEX IRRIGATION**

**WHEREAS**, the Department of Public Works is responsible for the management and upkeep of all Township facilities and grounds; and

**WHEREAS**, the irrigation system at the Municipal Complex was removed in order to complete essential restoration work following flooding during Hurricane Ida in September 2021; and

**WHEREAS**, Director of Public Works Steve Bloyed has made a recommendation that the irrigation system be replaced in its entirety in order to support the maintenance of the Municipal Complex grounds; and

**WHEREAS**, funding for said project will be available in Account No. D-33-56-850-005-001; and

**WHEREAS**, the Business Administrator has reviewed the Director's request and recommends authorizing a contract for the Municipal Complex Irrigation project; and

**WHEREAS**, the aggregate amount for said goods and services is anticipated to exceed the current bid threshold, and is therefore required to be procured under a formal process pursuant the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

**NOW, THEREFORE, BE IT RESOLVED**, on this 24<sup>th</sup> day of March, 2025 that the Township Council of the Township of North Brunswick does hereby authorize advertisement for the receipt of bids for the following specification:
