

**TOWNSHIP OF NORTH BRUNSWICK
RESOLUTION 155-5.25**

**Authorizing the Rejection and Readvertisement for the Receipt of Bids Under the Department
of Public Works for BID25007 – Purchase of a Tandem Axle Truck**

WHEREAS, the Department of Public Works Road Maintenance Division is responsible for maintaining the Township's roadways; and

WHEREAS, the Division identified a need for an additional tandem axle truck to efficiently complete its work and Director of Public Works Steve Bloyed agreed with the assessment; and

WHEREAS, the aggregate amount for said goods and services is anticipated to exceed the current bid threshold, and is therefore required to be procured under a formal process pursuant the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

WHEREAS, on March 24, 2025 the Township Council of the Township of North Brunswick approved Resolution no. 119-3.25 authorizing advertisement for the receipt of proposals for the purchase of a tandem axle truck; and

WHEREAS, on April 8, 2025, the Municipal Clerk, witnessed the receipt of one (1) proposal submitted by Robert H. Hoover & Sons, Inc. (with offices at 149 Gold Mine Road, Flanders, NJ 07836); and

WHEREAS, the respondent submitted an Exceptions Form and the Township found the exceptions the respondent was requesting would not align with the intended use for the truck; and

NOW THEREFORE, BE IT RESOLVED, on this 5th day of May 2025, that the Township Council of the Township of North Brunswick does hereby reject all proposals received for Contract BID25007.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick hereby authorizes the re-advertisement and re-bidding of BID25007 for the receipt of proposals for the following:
