RESOLUTION 171-5.25**

**Resolution Authorizing Award of Contract BID25008 to Mack Mechanical LLC for HVAC
Maintenance and Repair Services**

WHEREAS, the Department of Public Works Building Maintenance Division is responsible for providing municipal facilities maintenance and repairs; and

WHEREAS, the Township currently does not have a maintenance and repair contract for the heating, ventilation and air condition (HVAC) systems at the various municipal facilities, and

WHEREAS, due to the complexity of the systems, Director of Public Works Steve Bloyed has made a recommendation that the Township engage in a contract with a licensed HVAC company; and

WHEREAS, on March 24, 2025 the Township Council approved Resolution 117-3.25 authorizing advertisement for receipt of bids for the HVAC Maintenance and Repair Services, BID25008; and

WHEREAS, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of eight (8) bids on April 22, 2025; and

WHEREAS, lowest responsive bid received was submitted by Mack Mechanical, LLC (10 Congress Circle, Medford, NJ 08055); and

WHEREAS, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by Mack Mechanical, LLC and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is the Director's recommendation to authorize a contract with Mack Mechanical, LLC under BID25008, for HVAC Maintenance and Repair Services for a one-year term beginning June 1, 2025, plus the option of one (1) two-year renewal, and an amount not-to-exceed \$50,000.00; and

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Mack Mechanical, LLC is hereby accepted.

BE IT FURTHER RESOLVED, on this 19th day of May 2025 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Mack Mechanical, LLC for the HVAC Maintenance and Repair Services, pursuant to contract BID25008, in an amount not-to-exceed \$50,000.00, with a one-year term (June 1, 2025 – May 31, 2026) reserving the option for one (1) additional two-year term.
