**Authorizing Award of Contract BID25007 To Robert H. Hoover & Sons, Inc.  
for the Purchase of a Tandem Axle Truck**

**WHEREAS**, the Department of Public Works Road Maintenance Division is responsible for maintaining the Township's roadways; and

**WHEREAS**, the Division identified a need for an additional tandem axle truck to efficiently complete its work and the Director of Public Works agreed with this assessment; and

**WHEREAS**, on March 24, 2025 the Township Council approved Resolution 119-3.25 authorizing advertisement for receipt of bids for the Purchase of Tandem Axle Truck, BID25007; and

**WHEREAS**, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of two (2) bids on May 21, 2025; and

**WHEREAS**, lowest bid received was submitted by Robert H. Hoover & Sons, Inc. (149 Gold Mine Road, Flanders, NJ 07836) for the purchase of a tandem axle truck for the price of \$164,921.00 and

**WHEREAS**, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by Robert H. Hoover & Sons, Inc. and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**WHEREAS**, it is the Director's recommendation to authorize a contract with Robert H. Hoover & Sons, Inc., under BID25007, for the purchase of a tandem axle truck for the price of \$164,921.00 and

**NOW THEREFORE, BE IT RESOLVED**, that the bid submitted by Robert H. Hoover & Sons, Inc. is hereby accepted.

**BE IT FURTHER RESOLVED**, on this 23<sup>rd</sup> day of June 2025 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Robert H. Hoover & Sons, Inc. for the purchase of a tandem axle truck the price of \$164,921.00.
