

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF
THE TOWNSHIP OF NORTH BRUNSWICK
CONFIRMING THE REAPPOINTMENT OF MARGARET SHIMALLA AS
MUNICIPAL COURT ADMINISTRATOR FOR
THE TOWNSHIP OF NORTH BRUNSWICK**

WHEREAS, after nearly 20 years of service to the Township of North Brunswick, Sheral Rossmann, the Certified Municipal Court Administrator of the North Brunswick Municipal Court, retired as of December 31, 2020; and

WHEREAS, on January 1, 2021, pursuant to N.J.S.A. 2B:11-10(b) and authorized under Resolution 28-1.21, the Council consented to the Mayor's appointment of Kim Molnar to serve as Acting Court Administrator for the Municipal Court of the Township of North Brunswick, until such time as a permanent appointment was made; and

WHEREAS, on February 1, 2021, pursuant to N.J.S.A. 2B:11-10(b) and authorized under Resolution 68-2.21, the Council consented to the Mayor's appointment of Kim Molnar to serve as Court Administrator for the Municipal Court of the Township of North Brunswick; and

WHEREAS, after over 28 years of service to the Township of North Brunswick in various roles within the Court, Kim Molnar, the Certified Municipal Court Administrator of the North Brunswick Municipal Court, retired as of March 31, 2024; and

WHEREAS, in anticipation of her retirement, proper notice was provided for qualified candidates to respond to the vacancy, and Township Officials worked with the Superior Court of New Jersey, Municipal Division Manager for the Middlesex Vicinage, on the interview and selection process in accordance with New Jersey Court Rule 1:34-3; and

WHEREAS, in March of 2024, pursuant to N.J.S.A. 2B:11-10(b) and authorized under Resolution 105-3.24, the Council consented to the Mayor's one-year provisional appointment of Deputy Court Administrator Margaret Shimalla to serve as the Court Administrator for the Municipal Court of the Township of North Brunswick; and

WHEREAS, the Mayor hereby reappoints Margaret Shimalla pursuant to N.J.S.A. 2B:11-10(a) et seq. to serve as Municipal Court Administrator for an additional one-year provisional term, retroactive from April 1, 2025 through March 31, 2026; and

WHEREAS, the Township Council wishes to consent to this one-year provisional reappointment of Margaret Shimalla to serve as Court Administrator for the Municipal Court of the Township of North Brunswick.

NOW, THEREFORE, BE IT RESOLVED on this 8th day of September 2025, by the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey, that pursuant to N.J.S.A. 2B:11-10(a) et seq., the Council hereby consents to the one-year provisional reappointment of Margaret Shimalla to serve as Court Administrator for the Municipal Court of the Township of North Brunswick, effective April 1, 2025 through March 31, 2026.
