**Resolution of the Township of North Brunswick Authorizing Award of Contract BID25003 to  
C-3 Technologies, LLC for the Construction of a New Public Works Fuel Pump Station**

**WHEREAS**, the Township owns and operates a Fueling Facility located at the Public Works Facility on Quarry Lane which dispenses gas and diesel fuel for municipal operations (vehicles, equipment, generators) as well as servicing the Board of Education, local Volunteer Fire Departments, and the North Brunswick First Aid and Rescue Squad; and

**WHEREAS**, the Director of Public Works advised that the fuel pump station is approaching 30 years old and is in need of upgrades to the underground storage tanks, equipment, and related software; and

**WHEREAS**, on February 18, 2025 the Township Council approved Resolution no. 94-2.25 authorizing advertisement for receipt of bids for the Fuel Pump Station, BID25003; and

**WHEREAS**, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of five (5) bids on April 29, 2025; and

**WHEREAS**, lowest bid received was submitted by C-3 Technologies, LLC (501 Adams Lane, North Brunswick, NJ 08902) in the amount of \$1,977,719.00 and

**WHEREAS**, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by C-3 Technologies, LLC and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**WHEREAS**, Keith Chiaravallo with CME Associates, appointed Township Consulting Engineers, has reviewed the bid submitted by C-3 Technologies, LLC and determined them to be qualified and responsive to the specifications outlined in the bid, producing an evaluation report enclosed herein; and

**NOW THEREFORE, BE IT RESOLVED**, that the bid submitted by C-3 Technologies, LLC (501 Adams Lane, North Brunswick, NJ 08902) in the amount of \$1,977,719.00 is hereby accepted.
