**NOW, THEREFORE, BE IT RESOLVED** on this 28<sup>th</sup> day of February 2025 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with Rainone Coughlin Minchello authorizing the assignment of all rights and obligations under the current agreement to be assumed by Rainone Coughlin Minchello to serve as Tax Appeal Counsel with an authorization not-to-exceed \$60,000.00 for calendar year 2025.
