

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK APPROVING A  
LARGE EVENT APPLICATION FOR THE 2025 YOUTH SPORTS FESTIVAL AND  
ACKNOWLEDGING THE REQUEST FOR MUNICIPAL SERVICES**

**WHEREAS**, the North Brunswick Youth Sports Festival is a nonprofit organization that assists in providing funding for local youth sports programs, including Adams AC Football and Cheerleading, North Brunswick Soccer Club, North Brunswick Baseball and Softball Association, and the North Brunswick Travel Basketball Association; and

**WHEREAS**, the North Brunswick Youth Sports Festival also contributes direct municipal support in the form of field maintenance and the purchase of sporting equipment; and

**WHEREAS**, pursuant to Ordinance No. 19-09, which amended North Brunswick Municipal Code §166-1 et seq., “Public Entertainment,” any event not hosted by the municipality that anticipates a large gathering requires prior approval by the Township Council. Such events include, but are not limited to, circuses, carnivals, fairs, festivals, concerts, exhibitions, car shows, parades, expos, fundraisers, scholastic events, competitions, multi-team sporting events, and athletic races or rides; and

**WHEREAS**, the North Brunswick Youth Sports Festival has submitted an application to the Municipal Clerk to hold a large event, known as the “2025 Youth Sports Festival,” which includes a request for the use of municipal services; and

**WHEREAS**, pursuant to Municipal Code §166-1 et seq., the applicant is responsible for paying the costs of all municipal services, including, but not limited to, services from the Department of Public Works, Parks Maintenance, Office of Emergency Management, and additional-duty Police services; and

**WHEREAS**, the North Brunswick Youth Sports Festival has requested that the Township consider waiving applicable municipal fees pursuant to §166-7 et seq., due to its nonprofit status and its role in raising funds that directly benefit youth programs and municipal services; and

**WHEREAS**, the Township Council agrees that, following the conclusion of the event, the Mayor may review the request and make a recommendation to the Council for consideration of a waiver of all or part of the municipal fees incurred.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, on this 5th day of May, 2025, that the Large Event Application for the 2025 Youth Sports Festival is hereby approved; and

**BE IT FURTHER RESOLVED**, that the Township Council acknowledges the request for a waiver of municipal fees under §166-7 et seq. and agrees to give such request due consideration after the event concludes and the related costs are reviewed; and

**BE IT FURTHER RESOLVED**, that notice of this action shall be published in the *Home News & Tribune* within ten (10) days of adoption, as required by law.
