## Authorizing an Amendment to Contract Bid23009 With Jen Electric Inc. for the Maintenance and Repair of Traffic Light Signals

**WHEREAS,** Traffic signals exist to control the flow of traffic to increase safety, manage traffic and travel times, and provide direction for drivers; and

**WHEREAS,** it was the Director of Public Work's recommendation to the Mayor and Council to solicit bids for the preventative maintenance and repair of the traffic signals within the Township of North Brunswick; and

**WHEREAS**, on September 5, 2023, pursuant to Resolution 266-9.23, the Township Council authorized the advertisement for the receipt of bids for the Preventative Maintenance and Repair Services of Traffic Signals, BID23009; and

**WHEREAS**, on Tuesday September 26, 2023, one (1) bid was received in response to BID23009 for the Preventative Maintenance and Repair Services of Traffic Signals; and

WHEREAS, lowest bid was submitted by Jen Electric Inc. (631 Morris Avenue Springfield, NJ 07081) in the amount of \$27,400.00 for a two-year term based on an estimated 25 hours, a 15% mark-up on parts, and a preventative maintenance schedule for traffic signals at Hermann Road/Linwood Place, Nassau Street/Remsen Avenue and the Hermann Road Pedestrian Light; and

**WHEREAS,** on October 2, 2023, pursuant to Resolution 307-10.23 and based off of the Director's recommendation, the Township Council authorized a contract with Jen Electric Inc. under BID23009 for the Maintenance and Repair of Traffic Light Signals for a two-year term, October 1, 2023 – September 30, 2025 with an option one (1) two-year extension in an amount not to exceed \$75,000.00; and

**WHEREAS**, the Director has recommended extending the contract with Jen Electric Inc. for an additional two years, extending the term to September 30, 2027; and

**NOW THEREFORE BE IT RESOLVED**, on this 28<sup>th</sup> day of July 2025, that the Township Council of the Township of North Brunswick does hereby authorize an amendment to the agreement with Jen Electric Inc. for the Maintenance and Repair of Traffic Light Signals to extend the contract term by two years to September 30, 2027, pursuant to BID23009.
