

**TOWNSHIP OF NORTH BRUNSWICK  
RESOLUTION**

**Authorizing Award of Contract Bid25009 to American Lawn & Sprinkler for  
Irrigation Maintenance Services**

**WHEREAS**, the Township has existing irrigation systems at the Municipal Complex and at five (5) of its public parks which fall under the purview of the Department of Public Works; and

**WHEREAS**, the irrigation systems should be regularly serviced to keep them in good working order; and

**WHEREAS**, Director of Public Works Steve Bloyed made a recommendation that the Township procure a contractor to perform preventative maintenance on the irrigation systems and make repairs as needed; and

**WHEREAS**, on April 21, 2025 the Township Council approved Resolution 142-4.25 authorizing advertisement for receipt of bids for Irrigation Maintenance Services, BID25009; and

**WHEREAS**, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of two (2) bids on June 24, 2025; and

**WHEREAS**, lowest bid received was submitted by American Lawn & Sprinkler (31 Park Avenue, Englishtown, NJ 07726) which included standard, overtime, and emergency rates; and

**WHEREAS**, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by American Lawn & Sprinkler and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**WHEREAS**, it is the Director's recommendation to authorize a contract with American Lawn & Sprinkler under BID25009, for Irrigation Maintenance Services for a one-year term beginning August 1, 2025, plus the option of two (2) one-year renewals, and an amount not-to-exceed \$25,000.00; and

**NOW THEREFORE, BE IT RESOLVED**, that the bid submitted by American Lawn & Sprinkler is hereby accepted.

**BE IT FURTHER RESOLVED**, on this 28<sup>th</sup> day of July 2025 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township
