19, 2023 which was memorialized by Resolution dated October 17, 2023 and expired on October

18, 2024; and

WHEREAS, the Applicant, QuikChek/Estate of Santos LaBarbera now requests a second

and final extension of said Use & Bulk Variance approval for a period of one (1) year until

October 18, 2025 and

WHEREAS, the Applicant, QuikChek/Estate of Santos LaBarbera. has indicated that it

was prevented from proceeding forward with the approval due to NJDOT permitting delays,

compliance with NJDEP Stormwater regulations and issues with the contract purchaser. Said

explanation was contained in a letter dated September 13, 2024 from Ronald L. Shimanowitz, Esq., counsel for the Applicant to the Board's Secretary; and

WHEREAS, the Applicant, QuikChek/Estate of Santos LaBarbera indicated that it would comply with a one (1) year extension until October 18, 2025 if the Board was inclined to grant an extension and as a condition of said approval will agree to have a Preliminary and Final Major Site Plan filed with the Zoning Board of Adjustment of the Township of North Brunswick prior to October 18, 2025; and

WHEREAS, the Zoning Board of Adjustment of the Township of North Brunswick was satisfied that the Applicant, QuikChek/Estate of Santos LaBarbera has established sufficient cause to receive a second and final one (1) year extension of its Use Variance and Bulk Variance approval until October 18, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Zoning Board of Adjustment of the Township of North Brunswick, this 10th day of December, 2024 that the Board hereby confirms by this Resolution the action taken by the Board on October 22, 2024 granting the Applicant, QuikChek /Estate of Santos LaBarbera a second and final one (1) year extension of its Use and Bulk Variance approval until October 18, 2025.
