

**TOWNSHIP OF NORTH BRUNSWICK  
RESOLUTION 331-10.25**

**Authorizing an Amendment to Contract Pro21056 With Watch Guard for Police Camera  
Software and Equipment Under State Contract #23-FLEET-33791 – NTE \$21,142.40**

**WHEREAS**, the Township of North Brunswick Police Department is responsible for the maintenance of its police body and vehicle camera equipment; and

**WHEREAS**, in October 2021, following damage from Hurricane Ida, Township Council authorized resolution no. 293-10.21 which included the purchase of 40 body-worn cameras and evidence management software, including related equipment, customer support and warranty (service) for five years through May 2027; and

**WHEREAS**, prior to Hurricane Ida, the Township had received for fiscal year 2022, a grant in the amount of \$185,458.00 towards the purchase of body-worn cameras; and

**WHEREAS**, due to changes in the scope of the grant, there is an additional balance that has to be expended by December 31, 2025 or the Township risks losing the funding; and

**WHEREAS**, the Police Director and command staff desire to purchase an additional ten body-worn cameras, two base stations, and service through May 2027 when the other 40 cameras' current warranty expires; and

**WHEREAS**, the State Division of Purchase and Property has awarded a contract to Watch Guard, with offices at 415 E. Exchange Parkway, Allen, Texas 75002 as an authorized distributor of Law Enforcement Firearms Equipment and Supplies under the New Jersey State Contract #23-FLEET-33791 (T0106); and

**WHEREAS**, at the request of the Township Police Department, Watch Guard has quoted State Contract pricing for this additional equipment, as detailed in the attached quote no. 3310295, in the amount of \$21,142.40; and

**NOW THEREFORE, BE IT RESOLVED**, that the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, does hereby authorize the Mayor and/or Business Administrator, on behalf of the Township, to execute an amendment to contract PRO21056 to include ten additional body-worn cameras and evidence management software, including related equipment, customer support and warranty for five years through May 2027, resulting in a net zero change in the initially authorized contract amount of \$537,409.00.
