**Authorizing Award of Contract to Hertrich Fleet Services, Inc. - New Jersey State Contract
No. 20-FLEET-01387 - Procurement of One 2026 Chevrolet Traverse AWD for the Sewer
Department – NTE \$41,805.50**

WHEREAS, the Sewer Department is responsible for maintaining the Township's sewer system and responding to sewer emergencies; and

WHEREAS, the Director of Public Works has indicated that the Sewer Department's Vehicle #815 (2008 Ford F-250) requires replacement by a comparable vehicle; and

WHEREAS, the Township of North Brunswick, in accordance with N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), is authorized by resolution to purchase goods and services through the State of New Jersey Cooperative Purchasing Program, without the need for public advertising for bids, for any State contracts awarded by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, Hertrich Fleet Services, Inc., with offices located at 1427 Bay Road, Milford, DE 19963 has been awarded New Jersey State Contract No. 20-FLEET-01387 (T2007) for Sport Utility Vehicles, Gasoline/Hybrid/Electric; and

WHEREAS, pursuant to Contract No. 20-FLEET-01387, Hertrich Fleet Services, Inc. is able to furnish the Township with a 2026 Chevrolet Traverse 4WD, LT for the price of \$41,805.50; and

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey does hereby to enter authorize an agreement with Hertrich Fleet Services, Inc. for the purchase of a 2026 Chevrolet Traverse 4WD, LT at cost not to exceed of \$41,805.50.
