Sai Pariwar, request for extension of time, was reprsented by James E. Stahl, Esq. Application was approved by the Board September 17, 2019, ROA December 3, 2019. This is the last extension of time to be granted, extension granted until June 3, 2026. No public.

Yvette Ford, 1281 Masoma Road, request for an approval of a 6' privacy fence in the front yard area of Axel Avenue. Jovan Ford spoke on behalf of application. No public.

Julie Langsam, 359 Tremont Avenue, Milltown, discussed the need for a bulk variance to expand kitchen in the rear yard area. Addition will be 10.6 feet from the side yard, where 12 feet is required; maximum impervious coverage will be 25.3%, whereas the maximum is 20%.
