**AUTHORIZING AWARD OF “NON-FAIR AND OPEN PROCESS” CONTRACT PURSUANT
TO N.J.S.A. 19:44A-20.5 - 2026 NORTH BRUNSWICK TOWNSHIP
POLICE ACCREDITATION CONSULTING SERVICES**

WHEREAS, the Township of North Brunswick has a need to acquire Police Accreditation Consulting Services for 2026 as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Township of North Brunswick has determined and certified that the value of the services to be rendered may exceed \$17,500.00

WHEREAS, the anticipated term of said contract is for a period of one year and shall run from January 1, 2026 through December 31, 2026; and

WHEREAS, Lexipol, LLC, 2611 Internet Blvd, Suite 100, Frisco, Texas has completed and submitted a Business Entity Disclosure Certification which certifies that Lexipol, LLC has not made any reportable contributions to a political or candidate committee in the Township of North Brunswick in the previous one year, and that the contract will prohibit Lexipol, LLC from making any reportable contributions through the term of the contract; and

WHEREAS, the Local Public Contracts Law, specifically, N.J.S.A. 40A:11-1, et seq., requires that a resolution authorizing the award of contract for professional services and/or extraordinary unspecifiable services without competitive bids must be public advertised, the within contract being one for generally recognized professional and/or extraordinary unspecifiable services, as defined by statute.

WHEREAS, N.J.A.C. 5:30-5.4 requires certification of available funds when such information is known at time of award, but if not available no payment shall be made unless Chief Financial Officer certifies available funds at the time the obligation is to be paid but the estimated maximum value of the contract is revealed in the RFP on file with the Municipal Clerk.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey does hereby award one (1) year contract to Lexipol, LLC for Police Accreditation Consulting Services for a term commencing January 1, 2026, and terminating December 31, 2026; and

BE IT FURTHER, RESOLVED that this contract is being awarded without competitive bids as a professional service under the provisions of the Local Public Contracts Law, more specifically addressed in the body of this Resolution; and
