**AUTHORIZING AWARD OF CONTRACT BID25016 TO MALOUF FORD LINCOLN FOR
ONE DETECTIVE VEHICLE (2025 FORD EXPLORER) – NTE \$41,689.00**

WHEREAS, there is a need to replace one (1) vehicle for the Detective Bureau in the Department of Public Safety's fleet that have exceeded their useful life, listed below; and

#506: 2008 Chevrolet Malibu

WHEREAS, on October 6, 2025 the Township Council approved Resolution 313-10.25 authorizing advertisement for receipt of bids for the Provision of a Detective Vehicle (1), BID25016; and

WHEREAS, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of two (2) bids on November 18, 2025; and

WHEREAS, the lowest bid received had an incurable defect and the next lowest bid was submitted by Malouf Ford Lincoln (2210 US Highway One, North Brunswick, NJ 08902) for one (1) 2025 Ford Explorer; and

WHEREAS, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by Malouf Ford Lincoln and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is the Director's recommendation to authorize a contract with Malouf Ford Lincoln, under BID25016, for one (1) 2025 Ford Explorers for the price of \$41,869.00 and

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Malouf Ford Lincoln is hereby accepted.

BE IT FURTHER RESOLVED, on this 15th day of December 2025 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Malouf Ford Lincoln for one (1) 2025 Ford Explorer, pursuant to contract BID25016, for the price of \$41,869.00.
