**AUTHORIZING AN AGREEMENT WITH HOGAN SECURITY GROUP FOR THE SUPPLY
AND INSTALLATION OF THE SALTO ACCESS CONTROL SYSTEM IN THE NORTH
BRUNSWICK TOWNSHIP MUNICIPAL COMPLEX – NTE \$93,091.46**

WHEREAS, the Division of Information Technology and the Department of Public Safety desire to expand the access control system in the Municipal Complex to enhance security and accountability; and

WHEREAS, the Township is very limited with its existing access control system, installed in 2018, which has exceeded its useful life and there are less than a handful of companies in the tristate area that will service it; and

WHEREAS, the abovementioned departments have explored various options with three reputable New Jersey companies and found the Salto Access Control System, offered by Hogan Security Group, LLC, to be the most affordable and scalable of the options available to us; and

WHEREAS, Hogan Security Group, LLC, 1569 Reed Road, Pennington, NJ 08534, is an approved vendor under the current Cooperative Pricing Agreement with the Hunterdon County Educational Services Commission HCESC Bid #218 for Mechanical & Electronic Door Locking Systems, Doors & Related Products; and

WHEREAS, Hogan Security Group, LLC, under Bid #218, has provided a proposal to supply and install the Salto Access Control System for the North Brunswick Township Municipal Complex at a price of \$93,091.46.

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with Hogan Security Group, LLC for \$93,091.46 to supply and install the Salto Access Control System for the North Brunswick Township Municipal Complex.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Hogan Security Group in accordance with the previously approved Hunterdon County Educational Services Commission HCESC Bid #218.
