**AUTHORIZING AN AMENDMENT TO THE AGREEMENT (PRO25077) WITH SANITATION
EQUIPMENT CORP. FOR THE PURCHASE OF A LABRIE AUTOMATED SIDE LOADER BODY FOR
THE DEPARTMENT OF PUBLIC WORKS UNDER ESCNJ CONTRACT – NTE \$3,418.83**

WHEREAS, the Department of Public Works' Director has indicated there is a need to purchase a new automated side loader garbage truck in order to decommission 2016 Auto Car that is currently in use; and

WHEREAS, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

WHEREAS, Sanitation Equipment Corp., 80 Furler Street, Totowa, NJ 07512, is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #23/24-04 for Trucks (Class 4 – 8); and

WHEREAS, Sanitation Equipment Corp. under Bid #23/24-04 provided a proposal in the amount of \$213,806.94 for a Labrie Automizer (33 yard) Automated Side Loader; and

WHEREAS, on November 3, 2025, the Township Council authorized a contract with Sanitation Equipment Corp. pursuant to Resolution no. 351-11.25 in the amount of \$213,806.94 for the purchase of a Labrie Automizer (33 yard) Automated Side Loader; and

WHEREAS, the Director has been notified by Sanitation Equipment Corp. that an additional part (Hot Shift PTO/Remote Pump Hydraulics) is required to be added to the truck body, increasing the purchase price by \$3,481.83 and increasing the total price to \$217,648.77; and

NOW THEREFORE BE IT RESOLVED, on this 15th day of December 2025 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute an amendment to the contract with Sanitation Equipment Corp. which reflects a net contract increase amount of \$3,418.83 for a revised contract amount of \$217,648.77.
