

Please see attached proposal revision to make the following changes:

- No action necessary for 122B Wood Door – this was factored in as a flush wood door in the previous proposal to accommodate design intent for lactation room.
- Add-alternate for (3) Borrowed Lite Frames has been removed.

- Welded frames have been switched to knockdown to accommodate project schedule. This is the only change to our base bid, so for breakout purposes this was a \$675 + TAX deduct.
- Add-alternate to expedite frames has been removed.
- Frames at Openings 006/010A have been punched & dimpled.
