**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AN AMENDMENT TO CONTRACT BID24013 WITH GIANOTTO ELECTRICAL
CONTRACTING FOR PROVISION OF ELECTRICIAN SERVICES – NTE \$50,000.00**

WHEREAS, the Township of North Brunswick under the Department of Public Works provides for the maintenance and repair of all Township grounds and facilities; and

WHEREAS, on September 16, 2024 the Township Council approved Resolution 283-9.24 authorizing advertisement for receipt of bids for the Provision of Licensed Electrician Services, BID24013; and

WHEREAS, on October 8, 2024, the Purchasing Agent received, and the Municipal Clerk, witnessed the receipt of two (2) proposals; and

WHEREAS, lowest bid received was submitted by Gianotto Electrical Contracting, LLC (242 Georgetown Road, Columbus, NJ 08022) which included hourly Journeyman and Apprentice rates; and

WHEREAS, on October 21, 2024, pursuant to Resolution 332-10.24, the Township Council authorized a contract with Gianotto Electrical Contracting, LLC under BID24013, for the Provision of Licensed Electrician Services, that includes a two-year term beginning October 21, 2024, plus the option of two (2) one-year renewals, and an amount not-to-exceed \$100,000.00; and

WHEREAS, on December 16, 2024, pursuant to Resolution 366-12.24, the Township Council authorized an increase of \$25,000 to the contract amount for a revised authorization amount of \$125,000.00; and

WHEREAS, on July 28, 2025, pursuant to Resolution 251-7.25, the Township Council authorized an increase of \$50,000 to the contract amount for a revised authorization amount of \$175,000.00; and

WHEREAS, on December 15, 2025, pursuant to Resolution 391-12.25, the Township Council authorized an increase of \$75,000 to the contract amount for a revised authorization amount of \$250,000.00; and

WHEREAS, due to the establishment of a secondary Emergency Operations Center and ongoing work at the Municipal Complex and other properties, the Director recommends authorizing an increase of \$50,000.00 to the current authorization, for a revised authorization amount of \$300,000.00; and

NOW THEREFORE BE IT RESOLVED, the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey does hereby authorize an amendment to the agreement with Gianotto Electrical Contracting, LLC for the Provision of Licensed Electrician Services, with an increase of \$50,000.00 to the current authorization, for a revised authorization amount of \$300,000.00
