**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AWARD OF CONTRACT BID26002 TO MALOUF FORD LINCOLN FOR THE
PROCUREMENT OF A VAN FOR OPIOID RECOVERY OUTREACH PROGRAMS – NTE \$51,639.00**

WHEREAS, in March 2022 the State of New Jersey reached an agreement on a national lawsuit against four companies for their role in the opioid crisis; and

WHEREAS, the Township has been the beneficiary of more than \$240,000.00 through this settlement which has been earmarked for use in programs that focus on treatment, prevention, and other strategies to combat the opioid epidemic; and

WHEREAS, on January 12, 2026 the Township Council approved Resolution 069-1.26 authorizing advertisement for receipt of bids for the Provision of a Van for Opioid Recovery Outreach Programs, BID26002; and

WHEREAS, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of two (2) bids on February 3, 2026; and

WHEREAS, the lowest bid received was submitted by Malouf Ford Lincoln (2210 US Highway One, North Brunswick, NJ 08902) for one (1) 2025 Ford Transit Van; and

WHEREAS, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by Malouf Ford Lincoln and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is the Director's recommendation to authorize a contract with Malouf Ford Lincoln, under BID26002, for one (1) 2025 Ford Transit Van for the price of \$51,639.00 and

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Malouf Ford Lincoln is hereby accepted.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Malouf Ford Lincoln for one (1) 2025 Ford Transit Van, pursuant to contract BID26002, for the price of \$51,639.00.
