**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AN AMENDMENT TO CONTRACT BID23004 WITH J. FLETCHER CREAMER & SON
INC. FOR SEWER AND STORMWATER COLLECTION SYSTEM MAINTENANCE AND REPAIR
SERVICES**

WHEREAS, the Department of Public Works Sewer Division is responsible for providing maintenance and repairs to the municipal sanitary system; and

WHEREAS, it was the Department Director's recommendation to engage a company in providing for Sewer and Stormwater Collection System Maintenance and Repair Services under Contract BID23004; and

WHEREAS, on May 15, 2023 pursuant to Resolution no. 155-5.23 the Township Council authorized an agreement with J. Fletcher Creamer & Son, Inc. (101 E. Broadway Hackensack, NJ 07601) in the amount of \$175,000.00 for a two-year term with the option of two (2) one-year renewals; and

WHEREAS, on May 15, 2023 pursuant to Resolution no. 155-5.23 the Township Council authorized an agreement with J. Fletcher Creamer & Son, Inc. (101 E. Broadway Hackensack, NJ 07601) in the amount of \$175,000.00 for a two-year term with the option of two (2) one-year renewals; and

WHEREAS, on June 9, 2025 pursuant to Resolution no. 196-6.25, the Township Council authorized a one-year extension to contract BID23004 with no change to the contract amount; and

WHEREAS, it is the desire of the Director of Public Works, Steve Bloyed, to continue to work with J. Fletcher Creamer on ongoing sewer and stormwater repairs that may arise; and

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey does hereby authorize an amendment to the agreement with J. Fletcher Creamer & Son, Inc., Inc. to provide Sewer and Stormwater Collection System Maintenance and Repair Services for a one-year extension of the contract term through April 30, 2027.
