**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING A FACILITY USE AGREEMENT FOR THE MUNICIPAL COMPLEX**

**WHEREAS**, the Township supports community engagement and the provision of fresh, local produce to residents; and

**WHEREAS**, the North Brunswick Police Benevolent Association (PBA) and the Superior Officers' Association (SOA) have requested permission to use the Municipal Complex to host a seasonal Farmers Market from May 2026 through September 2026; and

**WHEREAS**, the Farmers Market is proposed to take place on five (5) Fridays during the season, consisting of one (1) Friday in each of the months of May, June, July, August, and September; and

**WHEREAS**, the event may include a farmer's market, food trucks, music, and other related activities intended to enhance community engagement and support local vendors; and

**WHEREAS**, the governing body finds that permitting such use of the Municipal Complex serves a valid public purpose and benefits the residents of the Township.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Township of North Brunswick, County of Middlesex, State of New Jersey, that:

1. The North Brunswick Police Benevolent Association and the Superior Officers' Association are hereby authorized to enter into a Facility Use Agreement for use of the Municipal Complex for the purpose of hosting a Farmers Market on five (5) Fridays between May 2026 and September 2026, subject to the terms and conditions set forth therein.
2. The events may include farmers market vendors and may also include food trucks, music, and related activities customary to a farmer's market, subject to applicable laws, ordinances, and municipal requirements.
3. All applicable municipal permit and application fees associated with the authorized events shall be waived.
4. The Facility Use Agreement shall require the PBA and SOA to comply with all applicable insurance, indemnification, safety, and operational requirements as determined by the Township.
