**RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK  
AUTHORIZING THE SOLICITATION AND AWARD OF CONTRACT BID26006 TO  
STATIC POWER CONVERSION SERVICES, INC. - UPS REPLACEMENT  
AT THE MUNICIPAL COMPLEX - NTE \$56,372.00**

**WHEREAS**, the Township of North Brunswick is responsible for ensuring the reliable operation of critical infrastructure, technology systems, and public services within the Municipal Complex buildings; and

**WHEREAS**, the existing Uninterruptible Power Supply (UPS) system located at the Municipal Building provides backup electrical power that protects essential equipment and systems from power interruptions, voltage fluctuations, and outages; and

**WHEREAS**, the current UPS system has reached the end of its useful service life and is no longer capable of reliably supporting the operational needs of the facility; and

**WHEREAS**, failure of the UPS system could result in disruption of critical services, loss of data, damage to sensitive equipment, and interruption of governmental operations; and

**WHEREAS**, replacing the UPS system will improve system reliability, ensure continuity of operations, and protect essential technology infrastructure; and

**WHEREAS**, current Mechanical Engineering firm T&M Associates, Public Works Director and the IT Department have evaluated the current system and recommends replacement with a modern UPS system that meets current operational and safety standards; and

**WHEREAS**, the Township advertised BID26006 UPS Replacement – Municipal Complex on February 20, 2026; and

**WHEREAS**, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of seven (7) bids on March 4, 2026; and

**WHEREAS**, the apparent low bid received was submitted by Static Power Conversion Services, Inc. (1375 Strykers Road Phillipsburg, NJ 08865) for the purchase and delivery of one (1) Eaton 93PM UPS module with cabinet in the amount of \$56,372.00; and

**WHEREAS**, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by Static Power Conversion Services, Inc. and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and
