**RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK  
AUTHORIZING THE AWARD OF CONTRACT BID26005 TO CDR ELECTRIC LLC  
FOR THE BABBAGE PARK PARKING LOT LIGHTING IMPROVEMENTS PROJECT**

**WHEREAS**, the Township of North Brunswick desires to undertake lighting upgrades at the Babbage Park parking lot, including the removal of existing fixtures and the installation of new LED lighting fixtures and poles to be owned and maintained by the Township; and

**WHEREAS**, in May 2025, pursuant to Resolution 156-5.25, the Township Council authorized a Professional Services Agreement with USA Architects, Planners + Interior Designers, Ltd. for services associated with the Babbage Park Parking Lot Lighting Improvements Project; and

**WHEREAS**, in February 2026, the Township issued an advertisement for the receipt of bids for the Babbage Park Lighting Project, Contract BID26005; and

**WHEREAS**, on March 17, 2026, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of six (6) bids, as documented in the attached Clerk's Certification; and

**WHEREAS**, the lowest responsive and responsible bid was submitted by CDR Electric LLC, located at 47A Fairmount Road West, Califon, New Jersey 07830; and

**WHEREAS**, USA Architects, the Purchasing Agent, and Legal Counsel have reviewed the bid submitted by CDR Electric LLC and have determined it to be responsive and the bidder to be responsible in accordance with the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.;

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, that the bid submitted by CDR Electric LLC is hereby accepted; and

**BE IT FURTHER RESOLVED**, that the Mayor is hereby authorized to execute, and the Township Clerk to attest, an agreement with CDR Electric LLC for the Babbage Park Parking Lot Lighting Improvements Project, pursuant to Contract BID26005, in an amount not to exceed \$129,973.00.
